
SOUTH HADLEY ELECTRIC LIGHT DEPARTMENT BOARD OF COMMISSIONERS EXECUTIVE SESSION VIRTUAL MEETING FEBRUARY 29, 2024, AT 4:00 P.M.

Present for Board: Chair John Hine, Vice Chair Denise Presley, Paul Dobosh, Ron Coutu, Kurt Schenker (arrived 4:04)

SHELD Attendees: General Manager Sean Fitzgerald, Financial Manager Michael Conchieri, Administrative Assistant Kim Mendoza, Engineer Matt DelMonte

The virtual meeting open session was called to order by Chair John Hine at 4:00PM, then Mr. Coutu motioned, and Mr. Dobosh seconded, a move into Executive Session pursuant to M.G.L. c. 164, § 47D, for the purposes of considering property, discussing battery storage and fiber projects as stated by the Chair in open session.



DeLorean Battery Storage Project Update: DeLorean has reservations about the ability to run the necessary power line into the land on Old Lyman Road for the battery storage project because it would require crossing an Eversource easement. SHELD has investigated the original easement, on the SHELD owned property, which was issued to Eversource.



Mr. Fitzgerald said there is no action to be taken by the Board. Mr. Coutu commented that he knows people at Eversource, and he can reach out to them if needed.

Fiber Growth Update: Last year the Board approved possible SHELD ISP opportunities with Fiber Worx in Vermont and the Greater Portland of Maine Council of Governments (COG). Both projects are no longer viable for SHELD.

A new opportunity has materialized with the Town of Longmeadow. SHELD was contacted by their Telecom Committee and presented our ISP services to the committee. They toured our facilities yesterday, 2/28. They are interested in a town wide fiber build out and are voting to become their own fiber MLP this year. They are asking for our project management services and forecasted project costs. SHELD management recommends we pursue this opportunity and requests board approval to take the necessary actions to become the project manager and ISP for the Town of Longmeadow. If they decide to move forward with SHELD, we will manage everything from procurement to construction completion, and customer service to billing for the project.

The project would be overseen by Bobby Liswell, Lee Masters, Matt DelMonte, and the SHELD/Fiberspring team. Mr. Fitzgerald and Matt DelMonte gave more details on the construction process, such as using vendors Precision Valley and Sertex, and filing pole applications with Eversource and Verizon for make ready work. SHELD would also need to hire 2 more fiber techs and buy 2 more bucket trucks.

Longmeadow is looking for more information and pricing from SHELD, while they go through the process of becoming an MLP. Mr. Hine asked for a motion to authorize Mr. Fitzgerald to move forward with the Longmeadow fiber project.

On a motion by Mr. Dobosh, seconded by Mr. Schenker, it was VOTED: To authorize the General Manager to proceed with engaging with Longmeadow to provide fiber services, by a roll call vote: Ms. Presley-aye, Mr. Coutu-aye, Mr. Schenker-aye, Mr. Dobosh-aye, Mr. Hine-aye.

Adjourn:
